ADDITIONAL CONDITIONS

1. **SERVICE TAX:**

- a) It is mandatory for all the contractors (who are covered and entitled under Service Tax Rules) to have Service Tax Registration No., failing which tenders may not be issued them.
- b) Those who are not falling in Service Tax criteria as per their yearly turn over, shall give an undertaking as per attached sheet and shall owe all responsibility of Service Tax arises, if any, in future. THE UNDERTAKING AS PER ATTACHED SHEET MUST ACCOMPANY IN COVER NO.1 ALONGWITH UNCONDITIONAL ACCEPTANCE, OTHERWISE TENDER SHALL BE REJECTED.
- c) Service tax shall be calculated and shown separately in their bills /invoices, while claiming Service tax. It shall be shown in all bills whether Running or Final.
- d) All the bills / invoices shall have service tax registration nos. printed or stamped.

2. **EARNEST MONEY DEPOSIT:** As per the Contract Administration Proforma.

3. **POLICE VERIFICATION:** The Contractors who have been awarded the job through Work Order shall furnish necessary Police Clearance Certificate in respect of character and antecedents of all Contract Labourers engaged by them, before commencing the work at site.

This will be a part of Contractual Agreement, as entire Airport including Air India Complex has been declared as "**Prohibited Area**". All such Contractors who would be awarded contracts are required to comply with the above requirements.

Contractors shall obtain such Police Clearance Certificate from Police available against a nominal fee per Certificate and they will submit this Certificate giving Work Order reference on it, to the Office of the Engineer In Charge of Properties & Facilities Dept., to be forwarded to our Security Department along with request for issuance of Entry Passes.

ADDITIONAL CONDITIONS

4. Following amendment is to be added to the Conditions of Contract after Para 20.7.0 Page No. 15:

20-8-0 It shall be the Contractor's obligation to comply with all applicable statutory requirements including in particular relating to minimum wages and the dearness allowance and emoluments payable to the employees. It shall be the Contractor's responsibility to furnish each month to Air India due compliance of all statutory requirements.

20-9-0 In the event of Air India incurring any liability by reason of any lapse and / or omission on the part of the Contractor, the Contractor shall, from time to time, and at all times, indemnify and keep indemnified Air India against all such liability including the cost thereof on Attorney and client basis.

5. Our General Conditions of Contract and Specifications Volumes - I, II & III are both applicable. The same are available in Administrative Section of PFD and can be purchased, if required

6. **QUOTATIONER SHOULD QUOTE THEIR RATES OF INDIVIDUAL ITEMS AND FOR REBATE OFFERED IN FIGURES AS WELL AS IN WORDS. IF THE RATES ARE NOT QUOTED IN WORDS IN ADDITION TO FIGURES, SUCH TENDERS WILL BE REJECTED. INCOMPLETE QUOTATION IN ANY FORM SHALL BE REJECTED.**

In case of Term Contracts, the percentage variation quoted by the contractors on the basis of AI Standard Schedule of rates should be quoted in figures as well as words. The quotation where percentage variation is not written in words will be liable to be rejected.

7. **PERFORMANCE GUARANTEE & RETENTION OF SECURITY DEPOSIT**

As per Conditions of Contract, page No.7, Clause No.9.0.0 Security Deposit amounting to 10% of the completed contract value is retained with the department for the period of Defects Liability Period, which is normally 06 months from the date of completion of the work. While releasing final bill, 5% of the Security Deposit is returned to the party, thus retaining remaining 5% for the Defects Liability Period. In case of water proofing work specific provisions as contained in Specifications Booklet Vol.I, Page No.43, Clause No.2.0 stipulate the Security Deposit amounting to 10% of the value of the work shall be retained with the department for three years in case of bitumen tar felt water proofing and five years in case of cement based water proofing treatment.

8. AMENDMENT TO PRICE ADJUSTMENT CLAUSE IN CONDITIONS OF CONTRACT BOOKLET

9. PURCHASE PREFERENCE POLICY FOR PSE

" Preference shall be given for Products & Services offered by Public Sector Enterprises" as per prevailing orders of Govt. of India.

10. CONTRACTOR'S ALL RISK POLICY

As per the site conditions, the Engineer-in-charge will decide whether the CAR Policy is required for the subject work.

11. Intending Tenderers are advised in their own interest to visit the site of work and familiarise themselves with the site conditions before submitting their quotations.

12. The Contractor will not be entitled for any compensation due to enactment of any law regulation, etc. on account whether the same is/are enforced by state central Govt. during the tenure of the contract. Any other Tax like Sales Tax on works contract, Tax of levy, octroi, excise duty etc. on materials or any elements in respect of this contract shall be payable by the contractor and Air India will not entertain any claims whatsoever in this respect. The contractor's rates should cater for the same.

ADDITIONAL CONDITIONS

13. Rates for all items must cover the cost of all appropriate materials, labour, machinery, scaffolding, tools and plants and all appliances what so ever necessary for the complete execution of the work.
14. Mobilisation advance shall not be paid by Air India Ltd. on any account.
15. Various work permits as applicable for the job with reference of safety precautions will have to be obtained from regulatory sections of Air India before starting of the various works.
16. The contractor shall adhere to the rules, regulations and instructions of Security Dept. of Air India Ltd.
17. Every activity in connection with the subject work shall be carried out necessarily with the prior permission of EIC or his representatives.
18. 'Air India' and 'NACIL' are same and wherever Air India word is reflected, same can be read as 'NACIL'.
19. Before commencement of work, contractors are required to fill up and get approval of "work permit" for working at height from competent authorities in daily basis. This is mandatory requirement when workers are working at height more than 5 feet from floor level.
20. Contractors are required to procure adequate numbers of safety harness, helmets etc. duly approved by EIC before commencement of work at his own cost.
21. It should be distinctly understood that Air India reserves the right to split the tender among different characters as it may desire or issue 'Fractional Work Orders' to any other Contractors. If you could not progress the work as desired by Air India and no objection to this procedure shall be raised by you or any claim for compensation be raised because of such procedure.
22. Debris to be dumped at designated places only, at the end of the day's work. You will not be allowed to dump near the work in progress. If you will not be able to remove the debris within 7 days out of Air India premises, same will be carried out by Air India at your risk and cost. The amount will be recovered from your bill towards the expenses incurred by Air India to do the same.

23. Contractors may please note, that in case of deviation in the item or use of materials other than specified under instructions of EIC (Allowed due to non-availability or otherwise) same shall be dealt in rates as under:
“Difference in the cost of materials specified and actually used including taxes plus 20% overhead & profits (on the difference in cost of materials) shall be deducted from quoted rates in case of used material cost is lower than specified or paid extra in case of cost of materials are on higher side than specified as the case may be”.
 The labour cost if extra or on lower side, shall be delt similarly.
24. Description given in the attached Schedule of Rates - 2009 are only generally indicative of the type of work intended to be executed. Likewise, the quantities given in the Schedule should not be considered to be precise and are meant merely as a guide to the tenderers and are liable to vary according to the exigencies of work. It must be clearly understood that the Contractors before quoting, have fully acquainted themselves with the intend of:

1. The work shall be executed in such a way as to cause minimum inconvenience to the department concerned & the staff on duty. Special care & precautions shall be taken while painting so as not to stain machinery, furniture, glass panes etc. already painted ducts, windows and / or doors etc.
2. The furniture & other movable items shall be shifted, as required during the course of work & replaced in their original positions after completion of work. The floor, furniture etc. shall be covered with gunny bags, tarpaulin etc. during the course of work so as to avoid stains on floor or furniture etc.
3. The surface after painting shall present a smooth & uniform appearance & should not show brush marks, patches or any other faults. The contractor shall make good any such defects at his own cost & his having applied the specified number of coats shall be no criterion for his having completed the job satisfactorily. All such defects shall be readily attended to & rectified to the entire satisfaction of Engineer-in-Charge or his representative.
4. The rates quoted shall be valid for the full contract period. Air India Ltd. is not concerned with fluctuations or variations in prices, duties, taxes etc. of paints & other materials, labour charges & no escalation in the rates quoted shall be allowed for any reason whatsoever.

5. The painting works, if so directed may be carried out on Sundays, Holidays & during night time. The rates quoted shall be valid for the same. Similarly, the rates are to be valid for work at any height or level.

6. Necessary entry passes for contractor's workers shall be issued by Air India Ltd. However, these workers shall be controlled by a full-time & responsible supervisor employed by the contractor. They should confine to their own work area & shall not roam about or meddle with any equipment, material belonging to Air India Ltd.

7. It is necessary that the contractor maintains standard force of at least 8 to 10 workers with their mukadam & technical supervisor, who will take instructions for painting jobs from the Engineer-in-Charge or Zonal Supervisor of Air India Ltd. All painting jobs must be attended to promptly. Unless otherwise stated, the painting work shall commence within 48 hours of issue of fractional work order. The work shall be planned & executed in consultation & co-ordination with the User Dept., as well as the Engineer-in-Charge / Zonal Supervisor. The contractor's supervisor shall meet the Engineer-in-Charge everyday & inform him about the commencement & progress of work.

Before commencing any painting work, all materials required for the same must be got approved from the Engineer-in-Charge. Contractors shall make at their own cost proper secure arrangements for storage of paints & other materials to be used in various works. The storage of materials shall be open for inspection at any time to the Engineer-in-Charge, or his representative. A proper register shall be maintained for the painting materials brought to the Air India premises & it shall be available for inspection at any time to EIC or his representative. All paints, stainers, lacquers, thinner & other paint materials shall be brought & stored in the manufacturer's original containers. Paints shall not be stored in open containers. If the same becomes unavoidable, the paints in the open containers shall be covered with thin layer of turpentine to prevent formation of skin at the top. Any paint, which has become 'Stale' or 'Flat' due to long storage shall not be used on any work but removed from the site as directed.

9. The contractor shall prepare samples of paint on walls etc. for deciding colour scheme for the approval of the Engineer-in-Charge at no extra cost.

10. The contract shall be valid for a period of 12 months. At the end of the contract period, if mutually acceptable the contract may be extended on the same terms & conditions for a further period of a maximum of six (6) months.

11. The quantities given in the schedule should not be considered to be precise & are merely as a guide to the tenders & are liable to vary according to the exigencies of work. Separate fractional work orders will be issued to the successful tenderer from time to time for different works on the basis of the main work order.
