ADDITIONAL CONDITIONS

1. **SERVICE TAX:** As per Govt. of India notification, it is mandatory for the Contractor (Service Provider) to pay the Service Tax to Central Excise Department and the same shall be reimbursed by NACIL on production of the documentary proof of payment. The service Tax shall be of 10.30% or revised time to time on the cost of labour for the work executed. It is also notified that the Contractor shall register under Service Tax category and get a registration number from the Central Excise Dept. for this work.

In case additional condition is include saying that the rate quoted should be inclusive of all statutory payments including VAT and Service Tax, no separate payment will be made towards Service Tax and Indemnity Bond will be obtained from the contractor on Stamp Paper indemnifying NACIL from the responsibility of paying Service Tax.

2. **EARNEST MONEY DEPOSIT:** As per the Contract Administration Proforma.
3. **POLICE VERIFICATION:** The Contractors who have been awarded the job through Work Order shall furnish necessary Police Clearance Certificate in respect of character and antecedents of all Contract Labourers engaged by them, before commencing the work at site.

This will be a part of Contractual Agreement, as entire Airport including Air India Complex has been declared as "**Prohibited Area**". All such Contractors who would be awarded contracts are required to comply with the above requirements.

Contractors shall obtain such Police Clearance Certificate from Police available against a nominal fee per Certificate and they will submit this Certificate giving Work Order reference on it, to the Office of the Engineer In Charge of Properties & Facilities Dept., to be forwarded to our Security Department along with request for issuance of Entry Passes.

4. Following amendment is to be added to the Conditions of Contract after Para 20.7.0 Page No. 15:

20-8-0 It shall be the Contractors obligation to comply with all applicable statutory requirements including in particular relating to minimum wages and the dearness allowance and emoluments payable to the employees. It shall be the Contractor's responsibility to furnish each month to Air India due compliance of all statutory requirements.

20-9-0 In the event of Air India incurring any liability by reason of any lapse and / or omission on the part of the Contractor, the Contractor shall, from time to time, and at all times, indemnify and keep indemnified Air India against all such liability including the cost thereof on Attorney and client basis.

5. Our General Conditions of Contract and Specifications Volumes - I, II & III are both applicable. The same are available in Administrative Section of PFD and can be purchased, if required

6. **QUOTATIONER SHOULD QUOTE THEIR RATES OF INDIVIDUAL ITEMS AND FOR REBATE OFFERED IN FIGURES AS WELL AS IN WORDS. IF THE RATES ARE NOT QUOTED IN WORDS IN ADDITION TO FIGURES, SUCH TENDERS WILL BE REJECTED. INCOMPLETE QUOTATION IN ANY FORM SHALL BE REJECTED.**

9. **PURCHASE PREFERENCE POLICY FOR PSE**
" Preference shall be given for Products & Services offered by Public Sector Enterprises" as per prevailing orders of Govt. of India.
10. **CONTRACTOR'S ALL RISK POLICY**
As per the site conditions, the Engineer-in-charge will decide whether the CAR Policy is required for the subject work.
11. Intending Tenderers are advised in their own interest to visit the site of work and familiarise themselves with the site conditions before submitting their quotations.
12. The Contractor will not be entitled for any compensation due to enactment of any law regulation, etc. on account whether the same is/are enforced by state central Govt. during the tenure of the contract. Any other Tax like Sales Tax on works contract, Tax of levy, octroi, excise duty etc. on materials or any elements in respect of this contract shall be payable by the contractor and Air India will not entertain any claims whatsoever in this respect. The contractor's rates should cater for the same.
13. Rates for all items must cover the cost of all appropriate materials, labour, machinery, scaffolding, tools and plants and all appliances what so ever necessary for the complete execution of the work.
14. Mobilisation advance shall not be paid by Air India Ltd. on any account.
15. Various work permits as applicable for the job with reference of safety precautions will have to be obtained from regulatory sections of Air India before starting of the various works.
16. The contractor shall adhere to the rules, regulations and instructions of Security Dept. of Air India Ltd.

ADDITIONAL CONDITIONS

19. Every activity in connection with the subject work shall be carried out necessarily with the prior permission of EIC or his representatives.
18. 'Air India' and 'NACIL' are same and wherever Air India word is reflected, same can be read as 'NACIL'.
19. Before commencement of work, contractors are required to fill up and get approval of "work permit" for working at height from competent authorities in daily basis. This is mandatory requirement when workers are working at height more than 5 feet from floor level.
20. Contractors are required to procure adequate numbers of safety harness, helmets etc. duly approved by EIC before commencement of work at his own cost.
21. It should be distinctly understood that Air India reserves the right to split the tender among different characters as it may desire or issue 'Fractional Work Orders' to any other Contractors. If you could not progress the work as desired by Air India and no objection to this procedure shall be raised by you or any claim for compensation be raised because of such procedure.
22. Debris to be dumped at designated places only, at the end of the day's work. You will not be allowed to dump near the work in progress. If you will not be able to remove the debris within 7 days out of Air India premises, same will be carried out by Air India at your risk and cost. The amount will be recovered from your bill towards the expenses incurred by Air India to do the same.
23. Contractors may please note, that in case of deviation in the item or use of materials other than specified under instructions of EIC (Allowed due to non-availability or otherwise) same shall be dealt in rates as under:
"Difference in the cost of materials specified and actually used including taxes plus 20% overhead & profits (on the difference in cost of materials) shall be deducted from quoted rates in case of used material cost is lower than specified or paid extra in case of cost of materials are on higher side than specified as the case may be".
The labour cost if extra or on lower side, shall be delt similarly with 15% overhead & profit.
24. Contractor shall carry out any additional works related to water supply & plumbing etc. required during the period of Term Contract as & when instructed by zonal E. I. C's such work shall be carried out by employing additional workers & materials. The contractor will be paid separately for such works on the basis of actual expenses of materials & labours + 20% DHP. Non- copopration & negligence in this matter will affect the Performance Appraisal Report of the Contractor. Also this shall be considered as non-oblegance & breach of contract A.I. Ltd. have the right to terminate the contract any time by giving 2 months notice.

ADDITIONAL CONDITIONS

25. Description given in the attached Schedule of Rates - 2009 are only generally indicative of the type of work intended to be executed. Likewise, the quantities given in the Schedule should not be considered to be precise and are meant merely as a guide to the tenderers and are liable to vary according to the exigencies of work. It must be clearly understood that the Contractors before quoting, have fully acquainted themselves with the intend of:

28. **The Contractor should make available at work site the plumbers/ operators in emergency such as Bandh/Riots/ Strikes/Natural calamities etc. With necessary arrangements in consultation with /as instructed by EIC of the zone. The entitled overtime + 15% profit will be paid to the contractor by NACIL-A after duly certification of concern EIC.**

SPECIAL CONDITIONS OF CONTRACT (for the subject work)

1. The Mumbai High Court in Writ Petition no. 3879 of 1990 has passed interim orders whereby NACIL and other respondents therein enjoined to maintain status-quo of 13 workers .Out of the 13 workers, one worker expired, two workers have resigned hence total following 10 workers. All these10 workers are required to continue and perform their normal duties. Further all these persons are required to be paid minimum wages. Tenderers are required to ensure while submitting their tenders that the orders of the High Court are not in any manner breached. The work has to be carried out through the following 10 workers only.

2. The Contractor shall be responsible for compliance with provisions of all applicable laws including minimum wages Act, labour laws in connection with the services to be rendered under this service agreement and in relation to the employees employed/engaged for rendering these services The contractor shall hold NACIL blameless in respect of any claims pertaining to or made by employees of the Contractor. It is clearly understood that this service agreement and arrangement thereunder shall not constitute any relationship of employer/employee between NACIL on one hand and employees of the Organisation on the other hand.

SPECIAL CONDITIONS OF CONTRACT *(for the subject work)*

3. Tenderers are requested to take note of the following important points carefully and submit their offers accordingly:

- a) Presently, the contract workers are to be paid daily wages @ Rs.230=47.
- b) Those contract workers who are working in Factory Areas and working more than 09 hours on any day or 48 hours in a week, will have to be paid overtime at double the rate.
- c) For others who are not working in Factory areas, overtime @ 1.5 times the daily rate will be applicable.
- d) No separate reimbursement will be made towards OT payment to workers. Contractors should take note of this and make suitable provisions while submitting their offer.

4 The Contractor has to take care of any statutory increase by Govt. of Maharashtra in minimum wages during the contract period. No separate reimbursement towards the same will be considered. However, if any revision / increase in wages over and above the statutory "Minimum Wages" is effected by Air India Ltd., following reimbursement only will be made by AIR INDIA LTD. in advance for a month and thereafter with the regular bills.

- a) Difference in statutory minimum wages prevailing at that time and the enhanced wages of Air India.
- b) Difference in OT due to the increase in item (a) above.
- c) Increase in Employees' Contribution towards ESIS / PF / BONUS at the prevailing percentages as applicable by law.
- d) Increase for compliance with statutory requirements due to enhanced wages.

5. Sufficient provision should also be made in their offer for tools / tackles, 2 sets of uniform one pair of shoes etc. per workman.

SPECIAL CONDITIONS OF CONTRACT

6. An amount of Rs.115/- (Rupees One Hundred and Fifteen only) per person per month will be recovered from monthly bills of the contractors towards Canteen subsidy.

7. a) The Contractor shall disburse the payment to all workers in cash/cheque by the 5th of every month, for the work done in the previous month.

b) Wages to be paid to workmen on or before the due date as irrespective of contractors' monthly bills clearance by Air India Ltd.

8 COMPLIANCE WITH STATUTORY REQUIREMENTS :

a) Implementation of various labour laws applicable to your establishments like the payment of Bonus Act, The Factories Act, ESI Act, The Workman's Compensation Act, the Payment of Wages act, The Minimum Wages Act, etc. will be carried out by the contractor, including that of submission of various returns under the labour laws applicable to the establishment including that of the Contract Labour (Regulation & Abolition) Act. The contractor will further carry out all the statutory obligations required under the above Acts & Rules and undertakes to indemnify Air India against any action initiated by the person engaged by the contractor for the performance of the contract as well as by any other third party against Air India for any damages.

b) If the workers are liable for any deductions, towards Income Tax and Professional Tax, the same will be deducted by you at source from the wages to be paid to them. The amounts so deducted will be deposited by you with the appropriate authorities and necessary certificates issued to the individual worker and file the annual returns as required under the laws. The receipt of such deposits shall be submitted to Air India before submission of the following month's bill.

9. TERMS OF PAYMENT :

a) The payment shall be made on monthly basis for the work carried out during the previous month.

b) However, the final value of the entire work shall be worked out and paid to you to the extent the work actually carried out by you as assigned and verified jointly.

SPECIAL CONDITIONS OF CONTRACT

10. The contractor shall remove from the premises their employees who are found to be failing in his/their duties for whose presence in the premises is otherwise objectionable in the opinion of the NACIL representatives/Security staff.

11. The successful bidder will have to enter into a service agreement with NACIL, in such form as may be required by NACIL for the performance of the work, which will be subject to these conditions and/or other Terms & Conditions, which may be considered necessary or expedient by NACIL.

12. It is suggested that the intending bidder / bidders or their representatives should visit the various areas to study the details and nature of services to be rendered before sending their quotations. The contractor will be deemed to have satisfied themselves as to the nature and the area of work, local facilities of access and all matters and things in any way affecting their rendering services as per the agreement including Security requirements. No claims for extra charges shall be entertained in this behalf for any reason whatsoever.

13. Any complaint received in connection with the services shall be attended to by the contractor immediately, through existing manpower or by temporary arrangement.

14. Canteen facility by NACIL will be made available to any of the workers of the Contractor. An amount of Rs.115/- (Rupees One Hundred Fifteen only) per person per month will be recovered from the monthly bill of the Contractor towards canteen subsidy.

15. All records pertaining to this contract should be maintained/ kept by the contractor and made available to EIC/NACIL(A) officers as and when requested.

16. The Contractor shall not enter into any sub-contract., without the prior written consent of the Competent Authority. The clause 44.1.0 is applicable.

SPECIAL CONDITIONS OF CONTRACT

17. **CONTRACT LABOUR ACT:**

The Contractor shall comply with all the labour rules and regulations for the time being and from time to time in force. He shall comply with the *Contract Labour (Regulation & Abolition) Act 1970* and the rules framed thereunder and the Minimum Wages Act, 1948 and the rules framed thereunder. The Contractor shall comply with all the applicable laws, Ordinance, Rules & Regulations in respect of this contract and the employment of the workers, provided by him and shall obtain all such municipal and other Govt. Permits, Licences and Inspections as may be necessary and shall pay at his own cost all charges in connection therewith. If NACIL. is required to make any such payments initially, the same will be deducted immediately from their monthly bills.

Contractors are advised to approach the concerned authorities directly (i.e. The Registering & Licensing Officer), so that the licensing authorities will decide as to whether the contracts are required to register with them and obtain Licences accordingly for the specific work contract and the work carried out by them for NACIL., irrespective of the manner of employees working under them are more or less than 20 under intimation to Properties & Facilities Dept., AI Ltd.

On receipt of the Works Order, the contractor shall prepare, produce, maintain and update various registers and records like register of persons employed, Employment card, Service Certificate, wage register, overtime register etc. as mentioned under the Act.

18. **CONTRACT LABOUR LICENCE:**

The contractor shall be governed under the Contract Labour (Regulation & Abolition) Act 1970 and he should obtain the Contract Labour License from the Labour Commissioner's office within 15 days from the date of issue of the Works Order. The contractor shall ensure that workmen and the supervisors employed by him shall not be minor age.

19. **RENEWAL OF CONTRACT LABOUR LICENCE**

The Contractor shall renew the Contract Labour Licence from time to time and inform the Departmental Representative accordingly.

SPECIAL CONDITIONS OF CONTRACT**20.EMPLOYEES STATE INSURANCE SCHEME:**

Contractor's workmen are required to be insured under the Employees State Insurance Act 1948. The contractor shall be solely responsible for any payment whatsoever in connection therewith including the cost of expenses required to be incurred in connection with the preparation and submission of returns etc. It will be the responsibility of the contractor to obtain the necessary code numbers as immediate Employer, payment of contribution at appropriate time to the ESIS authorities and also to ensure the availability of the facilities under ESIS to the employee. The contractor shall keep NACIL completely indemnified of all factors and aspects of Employees State Insurance Act and to the extent it may be applicable to this contract.

21. ESIS CONTRIBUTION:

Workers' contribution @ 1.75% of daily wages and O.T. payment, if any and Contractor's contribution @ 4.75 % of daily wages and OT payment, shall be paid to ESIS authorities by the Contractor directly and proof thereof, otherwise same shall be deducted by Air India Ltd. from each month's bill submitted by Contractor.

22. The contractor shall also ensure that the Contract Labour is medically fit and in sound mind and health.

23. PROVIDENT FUND CONTRIBUTION:

The successful contractor has to get ESIS & PF registration done with appropriate authorities within 21 days of issue of work order and document submitted to PFD, NACIL, failing which the contract shall be terminated without any notice, at your risk & consequences thereof. The work order shall be issued subject to the lowest bidder accepting this clause. Since the contract writ petition workers are under status quo, it is mandatory to have their PF /ESIS account as per statutory requirement valid all the time without any break. Also at the end of contract period, the contractor has to hand over all documents as required by statutory authorities for registering the workers with the next contractor. The Security Deposit which is retained in NACIL shall be returned subject to compliance of the above.

It is the contractor's responsibility to obtain the necessary registration codes for PF and EIS Card from the authorised and make payment of workers contribution @ 12% of daily wages and contractor's contribution @ 12% of daily wages alongwith 1.61% Administrative Charges shall be deposited with authorities & proof of payment shall be submitted to PFD, NACIL.

SPECIAL CONDITIONS OF CONTRACT

Any other charges, interest on account of late payment to the authorities shall be born by the contract.

The receipts of payments thus affected shall be submitted to PFD, NACIL. In the event of any failure in payment, the subsequent monthly bill shall not be processed. However the first month bill shall be processed by retaining the contribution and the same shall be released on submission of proof of payment.

Bombay Labour Welfare Fund Act, 1953

In addition to PF, ESIS contractor as to make payment under the above act @ Rs. 12/- per staff contribution and Rs. 36/- per contractor's contribution for half year. Necessary proof of payment has to be submitted to NACIL.

24. **YEARLY BONUS**

It shall be paid to the workers at the minimum rate of 8.33% of the gross amount of wages by the contractor.

25. **PERIOD OF CONTRACT:**

This contract is valid for a period of one year. However, if mutually acceptable by both parties, the contract may be extended for a further period of one year or part thereof on same terms and conditions.

26. **UNIFORM :**

Workmen deployed on duty shall be provided by the Contractor with two sets of Grey coloured Terrycot uniform consisting of full pants and half sleeve bush shirts; and one pair of shoes. The same shall not be payable by Air India Ltd.

While on duty, workmen shall wear the uniform. Contractor shall arrange the uniform within one month from the date of work order. Acknowledgement from each worker shall be obtained towards receipt of Uniform, failing which, per month/per worker, an amount of Rs.500/- will be deducted from the monthly bills. Recovery towards non-compliance of issue of uniform shall be made effective from commencement of work.

SPECIAL CONDITIONS OF CONTRACT

27. **DUTY ROSTER:**

The Contractor is requested to submit monthly a Roster of the workmen working in each shift, indicating timing, weekly off, place of work, to concerned Asst. Gen. Manager, before the beginning of each month.

The non-compliance of the instructions, habitual absenteeism, not observing timings / roster by the workers covered under writ petition, shall be brought to the notice of the Gen. Manager, Industrial Relations, Santa Cruz and copy to Properties & Facilities Dept.

The Attendance Register and Overtime Register should be procured by the Contractor and maintained by the Contractor's supervisor. The Attendance Register shall be signed by the workers and the same shall be kept in Properties & Facilities Dept. , Maint. Office at Bldg. no:28 at AI 1st. Hsg. Colony.

28. **E-MAIL ID:**

contractor shall mention E-Mail ID of their firm or of any personal individual so that instructions can be passed on for any important work/complaint in case contractors, supervisors/contractor himself is not available on specific day.

29. **PAYMENT OF OVERTIME:**

With regard to the payment of overtime to those contract workers, who are rostered in three shifts round the clock and working more than 48 hours per week or more than 9 hours a day in the Operational area (factory area) will be paid overtime at double the rate. The other utility contract workers other than operation area, the overtime will be paid at 1½ times. **No separate reimbursement will be made towards OT payment to workers.** Contractors should take note of this and make suitable provision while submitting their offer.

The contractor should mark clearly absenteeism of Operators /Plumbers in Attendance Register. In case of Operators who is not reporting on duty for particular shift should be marked absent & the payment dealt with. The operator continuing the duties or working in live of the absent one shall be paid accordingly.

30. Sufficient provision should also be made for tools / tackles, 2 sets of uniform and one pair of shoes per workman etc.

SCOPE OF WORK

Scope of work under this contract shall include the following:

Operation & Maint. of water supply, sanitary, plumbing and drainage installations in all the premises at Old Airport, Santa Cruz (E), Mumbai 400 029. The location of the pumps are listed in Annexure II. The contractor shall also maintain regular water supply for all offices, godowns, common areas, gardens etc. using borewell pumps.

IMPORTANT NOTES :

- i) Contractor shall also maintain water mains of any size from BMC or AI feeding to all buildings at Old Airport, Santa Cruz (E), Mumbai 400 029.
- ii) The Contractor shall prepare building & installation wise check off cards for periodic maintenance , predictive maintenance and preventive maintenance with frequency decided jointly with EIC. Break-down maintenance work carried out also to be recorded.
- iii) All works shall be carried out in accordance with latest IS specifications & codes. In the absence of any specifications & codes, International Specifications and codes shall be considered.
- iv) The Contractor shall plan and execute routine works with optimum manhours and mandays.
- v) Detailed scheduling of Preventive Maintenance works, special checks and restoration works etc. shall be made in advance as per the Tender. Approval for the same shall be obtained from the Engineer-in-Charge, including for any major material procurement
- vi) a) In order to control attendance / overtime allowances, the contractor should monitor continuously the attendance of contract workers and keep check on the absenteeism and pay their wages accordingly.
b) After assessing the quantum of all types of works, necessitating deployment of available contract workers in lieu of absentees, the contractor shall obtain prior approval from the Engineer-in-Charge for such deployment.

1. In addition to the pumps/motor included of Annexure II Contractor shall have to carry out the maintenance of existing installation.
2. The contractor shall carry out maintenance & servicing of pumps and motor so as to ensure smooth and efficient working of all pumps throughout the contract period. The Contractor shall send occasionally, experienced and skilled mechanic and electrician who shall attend maintenance work within the time schedule and submit Checklist / Report weekly to ensure release of their payment of monthly bills.
3. The responsibility for the maintenance of pumps, motors, starters etc. shall totally lie with the Contractor. They should periodically check for ensuring serviceability of the pumps, motors and other connected electrical installations, to ensure smooth working of the system. For the above, the contractor will liase day-to-day with the Engineer-in-Charge of E&M Section.

SCOPE OF WORK

4. All pumps & motors shall be serviced by experienced mechanic/electrician periodically as per Annexure I , III & A, for which party has to submit their offer/quotation against item no: 2 in Schedule of Quantities.
5. Electrical installation upto main switch of panel and starter is maintained by AI Ltd.
6. Regular checking & cleaning of electrical starters/switches shall be carried out under this contract.
7. Contractor shall have a detailed joint inspection alongwith representative from AI Ltd and previous contractor immediately before taking over the installation. The detailed list of any defect shall be pointed out during the inspection and specifically before taking over.
8. Any leakage due to gland packing of pumps or other wise is to be reported to the E&M Section and corrective action should be taken immediately. The contractor is required to carry out periodical greasing, replacing gland packing, inspection and cleaning of pumps, stainers, non-return valves and foot valves.
9. Pump to motor shaft and coupling should be periodically checked for alignment and tightness of nuts and bolts.
10. Motor terminals shall be checked periodically and any condition / irregularity in connection to be brought to the notice of E&M Section and corrective action to be taken as directed by them.
11. Motor or pump, when necessary shall be decoupled, removed and fixing to be done as directed by E&M Section.
- 12.a) Contractor shall ensure proper grounding earthing of motor starters and switches and any irregularity to be brought to the notice of the EIC of E&M Section.

14. In case of any failure/ breakdown of electrical system/ motors/ starters/ pumps etc., the same shall be brought to the notice of E&M section immediately. The contractor shall further follow up and render any assistance required for the rectification / repair work of the system.

SCOPE OF WORK

15. Contractor is required to carry out various checking of pumps and motors as given in the Annexure II & III for which no extra payment shall be made.

16. All the monthly maintenance bills will be submitted to the Competent Authority along with monthly roster, register, log book and performance certificate that "No Complaint" is pending in any area. All pumps/ motors / starters sets are in working condition in etc. from E&M section as per Annexure "A". & Log Book shall be maintained as per directions.

17. Mobile pumps shall be kept in perfect working order and necessary weekly test trials shall be carried out in the presence of E&M representative as per laid down norms. A register shall be maintained to record such tests. No extra payment shall be payable for attending to any type of breakdown.

C. PLUMBING / SANITARY MAINTENANCE:

1. Contractor shall employ adequate number of skilled Licence holders and experienced plumbers/operators, helpers, supervisors etc. who shall attend at the time of pumping hours as per instructions of the EIC for the smooth effective proper functioning of the contract.

2. Foot valves of every pump to be checked for proper functioning replacement whenever necessary, to be carried out as directed by EIC.

3. The necessary tools, appliances, special tools, scaffolding and other equipment required for the day-to-day maintenance/emergency works shall be arranged by the contractor at no extra cost

4. The contractor shall ensure the adequate water supply, carry out repairs/replacement and attending to plumbing / sanitary / drainage complaints including recording meter reading daily and maintaining log book for the same and shown to EIC daily. Whenever there is a shortage in water supply, the operators should inform the EIC immediately.

5. Spares / Replacement material like G.I pipes, taps, valves of any size and type plug, bend, T's pillar taps, PVC connector, washbasin with necessary fittings etc. will be supplied by AI Ltd. free of cost. In case the materials are not readily available in Stores, Contractor shall procure the same from market on urgent basis and attend to the complaint as per instructions of EIC and all such complaints shall be attended to within 8 hours from the time of receiving complaints, failing which compensation for delay shall be levied upon. Contractor shall be paid actual/ reasonable cost of material plus 15% towards overheads profit and transportation

6. Work under this contract is also covered for sanitary , plumbing installation & maintenance of internal and external water supply, drainage installations, tube wells, control valves, water meters, chambers etc. for various buildings in Old Airport .

7. Removing / replacing / repairing the bib taps, pillar taps, gate or wheel valves, sluice valves, nelson valves, plastic taps, metallic taps, etc. of any size / type

D Cleaning of Underground & Elevated and Over head water tanks:

Contractor shall clean under ground / overhead / elevated water tanks as mentioned in the subject, TWICE A YEAR , **in the months of April & October**, as instructed by EIC, **within the stipulated time, within the tenure of the contract.** RCC-UG tanks shall be cleaned using pneumatic / mechanised system and other OH & HDPC tanks shall be cleaned manually. Adequate labour, pump for emptying the tank, bleaching powder and cleaning material shall be provided by the Contractor at no extra cost without hampering the schedule as directed by EIC.

The bill towards tank cleaning will be included in the monthly bills of May and November.

ANNEXURE - I

1. In case of emergency, contractor shall arrange the additional staff for attending emergency faults at day or night time including Holidays without extra charges. In case of attending similar nature of emergency / urgent work at any other AI Ltd. Premises not covered under this contract, the contractor shall arrange the adequate staff as directed by the Engineer-in-Charge, shall be paid separately for such jobs based on actual expenses on labour and material / rate analysis with 20% OH profit & transportation

2. **TIME SCHEDULE:**

Plumbing Work:

Minor repairs : Repairs covered under this group consists of replacing / repairing and fixing new taps, stop cocks, pillar taps, PVC connector, bottle traps, ball cocks, float valves, etc. Shall be attended within 8 hours from the time of complaint.

Major repairs : Any breakdown in water supply line is required to be repaired / replaced on war footing basis and shall have to be attended to immediately, so as not to affect water supply but not later than 8 hours.

In case, for the above major / minor repair works, materials required is not readily available with AI Stores, it shall be the responsibility of the Contractor to procure the material from the market, which are required to works of minor or major repairs as per EIC's instructions. Under the circumstances, the Contractor shall be paid the reasonable market price of parts/spares plus 20% OH profit and transportation.

Sanitary Work : Any chokes inside the building (in wash basin, sink, toilet block, bath room) are needed to be removed immediately .

Repair to Pump / Motor : Any breakdown in this category needs to be attended to on war footing basis, but not later than 12 hours, so that water supply to the consumer can be maintained as per the schedule which is approved by the Engineer-in-Charge.

NOTE : For any emergency the contractor has to arrange necessary labour, i.e. plumbers, helpers, technicians etc. for immediate repairs.

5. Penalty for delay to attend to the complaints:

It is the responsibility of the contractor to ensure the rectification of faults within the time schedule indicated in para (2) above. In case of failure to rectify and complete the work as explained in Clause (2) above, within the time limit, an amount as specified below will be recovered from the contractor's bill.
