Viz. Earnest money, details of similar works completed, details of supporting documents regarding fulfilling of qualifying criteria of the tenderer/s, technical specifications, Drawings etc., and another envelope super scribed as <b><u>Cover 2 - Price Bid (Part-B)</u></b> which will comprise of price bid, along with the name of the work and tender notice number etc. Both the sealed covers 1 &amp; 2 are to be kept in a larger envelope superscribing the name of the work as noted above.
